



 - Currently licensed chiropractors




Snapshot

CIN-BAD Fees

- FCLB Member Boards: free unlimited access
- Accredited Colleges: \$250 per year / supply grad lists
- Non-Members:
 - \$500 per year subscription fee
 - + \$3.50 per lookup of first three alpha letters
 - + \$13.50 for any full reports (3% 5% of queries)
 - OR \$26 for staff conducted query
