3. Financial Report

a. Draft Outline of Financial Policies

Members and guests were provided with an initial draft of financial policies for ICRS. It was requested that comments and suggestions be provided to Ms. Cohen as soon as possible after members consult with their organizations.

b. Review of 2018 Financial Statement and 2019 Financial Projections
